### CLAIM FOR PROGRESSIVE TAXATION OF EARNED INCOME

This form for requesting the progressive taxation of earned income is for use by permanent residents of foreign countries, or individuals staying six months or less in Finland.

Residents of EEA countries or countries with which Finland has signed a tax treaty have the option of requesting that the 35% tax at source be replaced by progressive taxation of earned income (not including dividends).

Report all the income you have earned in Finland, earned income taxed in your country of residence, and the related deductions. Finland will only collect taxes on your income earned in Finland; however, the taxable income you have earned in your country of residence will raise the tax rate applied to your earned income in Finland.
