1 DESCRIPTION OF THE EXAMPLE

This example describes the reporting process when the payer pays income to an income earner in a situation where the grounds for the social insurance contributions are determined in a different way from the defined default values for the social insurance contributions of the income types. In the example, a meeting fee and a compensation for membership of a governing body are paid to a person in an employment relationship. Additionally, a fee is paid for an initiative not related to the work agreed in the employment contract. A EUR 100 expense also applies to the initiative fee that the payer deducts from the payment before withholding tax.

Each income type of the earnings payment report has a default for the payment of social insurance contributions. If the income is paid according to the default, the payer will not have to specially determine the social insurance contributions when submitting the report. For certain income types, depending on the situation, the basis for social insurance contributions may be different even if the payer is the same. For example, the basis for the payment of social insurance contribution may be whether the recipient of the payment is in an employment relationship or not. If the payment reported under the income type differs from the default, the payer selects Yes or No for Type of insurance information to specify whether the income type in question is grounds for an insurance contribution.

In the example, the payer has a valid pension insurance policy with an earnings-related pension provider, so the earnings-related pension provider data and the pension policy number are submitted in the earnings payment report. The accident insurance company details are not specified because the employer has insured all of its employees with one accident insurance policy.

Always check the instructions concerning the payment situation and enter all data matching the payment situation in question.

The data used in the example is not real. Always use correct data that matches the payment situation.
