1 DESCRIPTION OF THE EXAMPLE

This example describes the reporting of paid and unpaid absences and the reporting of reimbursement application data for paid absences. The absence data can be reported either together with the monetary wages paid or in a separate report. In this example, the data is reported separately.

The employer has a valid pension insurance policy with an earnings-related pension provider, so the earnings-related pension provider data and the pension policy number are submitted in the earnings payment report. Additionally, the company ID and policy number of the accident insurance company are reported, because the employer has insured its employees with two different accident insurance policies. This allows the data to be delivered correctly from the Incomes Register.

Always check the instructions concerning the payment situation and enter all data matching the payment situation in question.

The data used in the example is not real. Always use correct data that matches the payment situation.
