1 DESCRIPTION OF THE EXAMPLE

The employer pays wages, fringe benefits and expense allowances to a person in an employment relationship. The employer has a valid pension insurance policy with an earnings-related pension provider, so the earnings-related pension provider data and the pension policy number are submitted in the earnings payment report. The accident insurance company details are not specified because the employer has insured all of its employees with one accident insurance policy.

In this example, monthly wages have been paid and a telephone benefit and meal benefit have been granted, from which the payer has collected a compensation matching the tax value. The income earner has also been paid tax-exempt kilometre allowances. Some complementary data to an earnings payment report, such as employment relationship data, has also been specified in the example. Always check the instructions concerning the payment situation and enter all data matching the payment situation in question.

The data used in the example is not real. Always use correct data that matches the payment situation.
