# **1 DESCRIPTION OF THE EXAMPLE**

This example describes the entry of employment relationship data when a person retires on an old-age pension. The employer reports the data at the same time as paying the person's final wages and the annual holiday compensation. The example also describes the reporting of other voluntarily submitted employment relationship data. The employer has a valid pension insurance policy with an earnings-related pension provider, so the earnings-related pension provider data and the pension policy number are submitted in the earnings payment report. The accident insurance company details are not specified because the employer has insured all of its employees with one accident insurance policy.

Always check the instructions concerning the payment situation and enter all data matching the payment situation in question.

The data used in the example is not real. Always use correct data that matches the payment situation.
